A core program is the visiting Artist-in-Residence program that annually invites 7-9 artists to focus on their work while providing impactful community engagement and art programming through youth and teen workshops for public, private and homeschooled students both in schools and at CMCArts. Visiting artists are selected for their diversity in both culture and artistic disciplines to provide well rounded experiences and learning opportunities.
